- Head protection, Safety helmet fitted with a 4-point chin strap, ventilated Comply with applicable TZ standards, EN 397, ANSI Z87.1 or another equivalent international standard.
- Foot Protection, safety boots with slip resistant, EH protection & water & oil resistant upper, Comply with TZ Standard, EN ISO 20345-S3
- Protective Clothing, Coveralls or Combi-Suits with long sleeves, 100% cotton, light Fabric, with reflective striping and ventilations for shirts and trousers with relevant company Logo.
- Eyes protection, Safety glasses. Comply with applicable Local Standards, EN 166 or ANSI Z87.1 or AS/NZS 1336.
- Arc flash Cat 2 and CAT 4, comply with International Standard NFPA 70E.
- Other Addition PPE as required by end users such as, Hands protection, Rugged Glove clip, Fall Protection, Welding Protective, Hearing protection, Chemical Protective, Fire protective, Respiratory Protection, First aid and emergency rescue tools, safety tools etc.

- Proof of registration with the Tanzania Revenue Authority (TRA): TIN, VAT Registration, Tax Clearance Certificate for the latest year available.

- Compliance with Petroleum Local Content Regulations, 2017; and Local Company definition for Tanzania.
- Provide a Company Profile, Audited financial statements for the past 3 financial years and a Letter from your Banker(s).
- At least 5 years of demonstrable experience and financial capacity in delivering such services.
- Evidence of organization H3SE Management Systems, Policies and Procedure.
- Copy of Certificates of ISO 9001, ISO 14001, ISO 45001 or equivalent (as applicable).
